#### The Nation's First Institute to Prepare Nurses to Care for the ID/DD Patient Population

It was recently announced that the nation's first institute to prepare nurses to care for people with developmental disabilities will be opening at St. John Fisher College in Rochester, NY, after the college received a \$5.8 million gift from philanthropist Tom Golisano and the Golisano Foundation. The Golisano Foundation mission includes creating a better world for people with intellectual and developmental disabilities through its support of Special Olympics Health and many initiatives to promote inclusion and quality of life.

The Institute will be integrated into the Fisher's Wegmans School of Nursing and is designed to transform the health care and support of individuals with developmental disabilities. It will be the first institute of its kind in the country, and will have local, national, and international impact. It is recognized that nurses play a vital role as primary care providers in the healthcare setting, and preparing the next generation of nurses, nurse leaders, and creating a network of health care professionals can make a significant impact on improving access to both quality and inclusive health care for the ID/DD patient population.

Over the last year, our organization has collaborated with the Wegmans School of Nursing to be a resource and add to the knowledge base of the ID/DD patient population. The Institute is looking to continue its collaboration with nurse leaders in the field locally and on the national level as it moves forward with its agenda. Nurses in NYSIDDDNA are recognized as having the expertise to add value to this endeavor.

## Kathleen Keating, RN, MSN, CNP receives the 2018 Joyce Binder Award



Kathleen Keating, RN, MSN, CNP, nursing consultant and former Director of Nursing and Health Services, OPWDD, has been awarded the 2018 Joyce Binder Award. Nominated by numerous members, Kathy is described as "The Queen of Mentors" for

her "invaluable constant support and resource, for decades, for all nurses in our field". She has also been lauded for elevating the profession of nursing within OPWDD—a little known fact, Ms. Keating was the first RN to hold the position of Director of Health Services. Kathy also raised the status and visibility of I/DD Nursing to the State Board of Nursing, the DOH and CMS, as well as NYSNA, NYSARC, NYSACRA, and other advocacy and regulatory agencies.

In her retirement, Kathy continues to teach, advocate, guide and serve. She gives of her time to the Central Office Mortality Committee, the Surrogate Decision Making Committee, and many hours to her Church and Community activities. Kathy is also a prior recipient of the OPWDD Woman of the Year Award.

Ms. Keating joins prior recipients Patricia "Trish" Potocar and Karen Bazan in setting an example of how to exemplify the spirit of the Joyce Binder Award. The Joyce Binder Award is presented each year to an outstanding NYS ID/DD member who has made a significant contribution to advancing the practice of supporting individuals with ID/DD through the demonstrated attributes of caring/ compassion, advocacy, mentoring, leadership, dedication, and education/ research.

Recruitment Retention—including impact of The Justice Center Variations in survey expectations

The meeting was held Nov. 5, including Executive Board members Iellan Rice and Kelly Minde. The discussion centered around specific mechanisms to improve nurse wages, the NYS ID/DD Nurses Association Task Force to create a Standard Orientation Curriculum Development, The Justice Center, OPWDD actions to improve the survey process, and additions/revisions to the OPWDD Nurse Orientation to promote networking and professional development through membership in our Association. All agreed the meeting was productive and will lead to further opportunities.

#### NEW YORK STATE ID/DD NURSES ASSOCIATION October 1, 2018 Annual Meeting Syracuse, NY

President Darlene Langkau called the meeting to order at 7:45 AM. Opening remarks were made.

Lisa McHugh read last year's annual meeting minutes. Darlene made a motion to accept as read, seconded by Keith Collins-Allen. Minutes approved.

President Langkau reviewed the strategic plan – task forces will be giving report. Goal for increased conference attendance not met. There is discussion regarding fliers for interest and restarting the leadership track.

The scholarship winner for 2018 is Kate Hanson from Lexington ARC and is presently pursuing her RN.

Mary Boisvert presented the Treasure's Report- the Association is fiscally sound.
